

CERTIFICATION

Waiver of liability

Acceptance of the rules and specific conditions

- I hereby release the A-VELO association from any and all liability during the course of which, on the morning of each stage (6, 7 and 8 August 2025), a cycle ride is organised over the first few kilometres of the professional stage of the Tour de l'Ain: in respect of accidents and damage to property or personal injury that I may cause or suffer, in the event of theft or loss of property as well as any damage to the sites that may be attributed to it. It is therefore the responsibility of each participant to take out personal accident and/or equipment insurance, if they feel this is necessary.
- I also hereby waive all claims of any nature whatsoever, in particular in the event of accident, injury, theft, damage to personal property or other, occurring in the context of my participation in the event.
- I declare that I have Civil Liability insurance, covering me against all claims, of whatever nature, caused to me or to third parties by me, and that my insurance contract does not contain any clause contrary to what has been previously declared.
- I undertake to have my insurers waive any recourse against A-VELO and the Tour de l'Ain.
- I authorise any doctor to carry out or have carried out any medical and/or surgical intervention in the event of an emergency and/or to prescribe any treatment made necessary by my state of health.
- I acknowledge that presentation of this duly completed authorisation and liability waiver is compulsory and essential if I am to take part in the ride.
- I expressly and contractually authorise the Comité d'Organisation du Tour de l'Ain or its assignees to use or have used or reproduced or have reproduced, in return for my participation in the bike ride: my name, my image, my voice and my sporting performance with a view to any direct or derivative use of the operation and this, on any medium including for advertising or commercial purposes, throughout the world, by all means known or unknown to date, for 5 years from the date of signature of this document.
- These terms and conditions are governed by French law and are subject to the jurisdiction of the competent courts.

Specific conditions - Cycling

If I take part in the Tour de l'Ain x Crédit Mutuel bike ride

- I declare that I know how to ride a bike, that I own a bike in good working order and that I wear a helmet.
- I undertake to respect the highway code and to follow the instructions of the organiser, who has the right to refuse my participation in the event of unsuitable equipment or dangerous riding.
- I declare that I am in good health and fit to cycle; in this respect, I certify that I have no health contraindications relating to the proposed activity. In the absence of a medical certificate, I release the organiser A-VELO from all liability in the event of any incident whatsoever.
